



Livestock exhibitors,

This email serves as a reminder concerning possession dates, quality assurance, skillathon, Junior Fair registration, and market animal tagging. Please refer to the **March 19** email for all the details as this is just a reminder! Be sure to contact us with questions.

- **Livestock Possession Dates** – **April 1** for dogs, **April 15** for horses, market and breeding sheep, goats, hogs, breeding cattle, llamas/alpacas, breeding poultry, breeding rabbits, dairy; **May 15** for market rabbits and market chickens.
- **Tagging** – will take place this Saturday, **April 17**. Market hogs, goats, and lambs will tag from 9:00 am-12:00 noon. Dairy Beef Feeders will tag and weigh from 9:00 am-11:00 am. Dairy Beef Feeders will be vaccinated at the owners expense unless clear proof of prior vaccination is provided.
- **Quality Assurance** – **JUST 17 DAYS LEFT** to complete QA and submit your certificate to sharp.5@osu.edu. Go to <http://yqca.learnrow.io/Account/Login> for the training and quiz. Must complete **by May 1** or the member will not be able to show at fair. Required for market and lactating only.
- **Junior Fair Livestock Registration** – members have signed up for their projects through 4-H or FFA. Beginning on April 15, they must register the animals they are bringing to fair with the Livestock/Sale committee by **May 15**. Go to <https://pickaway.fairwire.com/> Instructions can be found at: <https://pickaway.osu.edu/program-areas/4-h-youth-development/pickaway-county-fair> All animals except poultry must have ID or tattoo to register. Make sure you sign up for Showmanship through the system as well. At the end you will receive a receipt via email. Check it for accuracy and keep it on hand. (Horses and Dogs will not use the online registration but have received paper forms instead.)
- **Fair Book** – The fair book is available online this year. Be sure you have read through the Junior Fair, ODA and specie rules. If you are taking a breeding animal, you may need to refer to the breeding class break-outs for your specie to sign up for the correct class. - **Livestock Skillathon Judging** – will take place on **June 10 and 11**. A schedule will be posted next month. Skillathon is required for all 4-H and FFA exhibitors taking any market animal, breeding animal, horse, or dog obedience/showmanship project to the fair. Early Judging is **June 2** by appointment. No late judging permitted.
